GENERAL SWIM CLUB POLICIES

- Loud or unruly behavior is not acceptable
- Proper attire must always be worn while outside of the designated pool area (shirt, shoes, and shorts/pants)
- Nudity is not permitted at any time. Partaking in public nudity or displaying obscene gestures may result in revocation of membership without refund
- Per San Diego County Health Ordinance: Persons having currently active diarrhea or who have had active diarrhea within the previous 14 days shall not be allowed to enter the pool water.
- Outside Food & Beverage is **NOT** permitted. This includes but is not limited to the pool deck, veranda, patios, restaurant space, conservatory areas, etc.
- Children under the age of 18 must be accompanied by an adult.
- **THERE IS NO LIFEGUARD ON DUTY AT ANY TIME**

PARKING

Parking on hotel grounds is permitted on all surface lot's; Mississippi, Louisiana and Howard Street. Although parking may say "Restricted" please feel free to park temporary. Overnight parking is an additional fee of \$22.00.

CANCELLATION POLICY

Cancellation may occur at any time, however, refunds will not be permitted for any remaining membership period.



FORCE MAJEURE

No damages shall be due for a failure of performance occurring due to inclement weather conditions, Acts of God, war, terrorist act, government regulation, riots, disaster, major maintenance requirements, or strikes, any one of which make performance or pool area use impossible.

INDEMNIFICATION

Each party hereby agrees to indemnify, defend and hold the other harmless from any loss, liability, costs or damages arising from actual or threatened claims or causes of action resulting from the negligence or intentional misconduct of such party or its respective affiliates (as applicable). The hotel or its' representatives are not responsible for lost or stolen items at any time.

PHOTO RELEASE

The pool is a public space and therefore photos/videos of the area may be taken and used for promotional, advertising, or publicity purposes. By signing this form, I authorize The Lafayette and its representatives to take, edit, alter, publish, distribute, and make use of any pictures or video of me to be used in and/or for legal promotional materials including, but not limited to, newsletters, flyers, posters, brochures, advertisements, press kits, websites, social media, and other print and digital communications without payment or any other consideration.

MISCELLANEOUS PROVISIONS

This contract is made and to be performed in San Diego County, California, and shall be governed by and construed in accordance with California law. By executing this agreement, the Member consents to the exercise of personal jurisdiction over it by the courts of the State of California. This contract is the entire agreement between the parties, superseding all prior proposals both oral and written, negotiations, representations, commitments and other communications between the parties, and may only be supplemented or changed in writing, signed by a representative of the group and the hotel's General Manager. No representative of the Hotel has been or is authorized to make any representation, which varies from the express terms of this contract, though this contract may be supplemented or amended in writing. In the event of litigation arising from or associated with this contract, the parties agree that the prevailing party therein shall recover its attorneys' fees and costs incurred therein. Any legal action in connection with this agreement shall be brought or maintained only in the courts of the State of California, and only in San Diego County. No food and/or beverage of any kind will be permitted to be brought into any hotel public facilities or designated pool areas, by members or any of the member's affiliates.
